## Summary

Using the Licensed Webfont(s) on the web, for styling HTML web pages, is permitted using the @font-face selector in CSS files and/or such other standard

## The License

The Print Designs by Kris (PDBK) Application Font End User License Agreement  
Version 1.2020

By downloading, installing and/or embedding font software ("Font") offered by PDBK or its distributors, you ("Licensee") agree to be bound by the following terms and conditions of this End User Licensing Agreement ("EULA"):

### 1. Rights Granted

PDBK grants Licensee a perpetual, worldwide, non-exclusive and non-transferable license to:

- The Licensed Webfont(s) may be used on any web site owned/controlled by the licensee. The total traffic, measured in page views, of web sites on which the Licensed Webfont is used must be no greater than the number of page views per month specified in the receipt you received for the Licensed Webfont.

### 2. Requirements and Restrictions

Licensee agrees to abide by the following requirements and restrictions:

- Agencies or others responsible for multiple clients' web sites, such as, for example only, web design agencies or hosting providers, may not use and/or share a single Webfont or other Font Software license to benefit multiple clients. Each user of Webfont Software must purchase a license that is proper for their own uses.
- You may not link to, nor make available online, any TrueType, OpenType or other version of the Font Software you may have licensed. The use of improperly used or non-licensed webfonts is also prohibited. You may not convert any standard Typetogether Font Software to any web font format.
- Agencies or others responsible for multiple clients' web sites, such as, for example only, web design agencies or hosting providers, may not use and/or share a single Webfont or other Font Software license to benefit multiple clients. Each user of Webfont Software must purchase a license that is proper for their own uses.
- The Licensed Webfont(s) may not be used in any interactive web applications where, by way of example only, not limitation, and subject to the relevant terms and conditions in the Typetogether EULA, where the:
  - a) end users can select and/or use any Licensed Web font for a text composition or editing use;
  - b) with respect to commercial uses, the Licensed Webfont(s) are used within an interactive web

or game application, a fee based application, an e-book, PDF document distributed for a fee, or an application that is distributed without charge which is used to promote a business's activity, services or products (except as may be otherwise provided under the License Upgrade, Embedding).

- You may not use conversion or editing tools or software to amend, modify or others change or alter the Licensed Webfont(s).

### **3. Term**

This EULA grants an annual license for the rights set forth in Paragraph 1 unless and until the EULA terminates under Paragraph 7.

### **4. Other Usage**

Licenses for desktop use, @font-face embedding, Ebooks and Epubs, product creation websites, website template distribution, website templates, and other uses not allowed by this Agreement may be available for an additional fee. Contact PDBK for more information.

### **5. Modifications**

Licensee may not modify the Font or create derivative works based upon the Font without prior written consent from PDBK EXCEPT THAT Licensee may generate files necessary for embedding or linking in accordance with this EULA.

### **6. Copyright**

The Font is protected by copyright law. PDBK is the sole, exclusive owner of all intellectual property rights, including rights under copyright and trademark law. Licensee agrees not to use the Font in any manner that infringes the intellectual property rights or violates the terms of this EULA. Licensee will be held legally responsible, and indemnifies Fontspring, for any infringements on PDBK rights caused by failure to abide by the terms of this EULA.

### **7. Termination**

This EULA is effective until terminated. If Licensee fails to comply with any term of this EULA, Fontspring may terminate the EULA with 30 days notice. This EULA will terminate automatically 30 days after the issuance of such notice.

The Product is provided "as is." PDBK makes no warranty of any kind, either expressed or implied, including, but not limited to the implied warranties of merchantability and fitness for a particular purpose.

PDBK shall not be liable for any direct, indirect, consequential, or incidental damages (including damages from loss of business profits, business interruption, loss of business information, and the like) arising out of the use of or inability to use the product even if PDBK has been advised of the possibility of such damages.

Because some states do not allow the exclusion or limitation of liability for consequential or incidental damages, the above limitation may not apply to Licensee.
